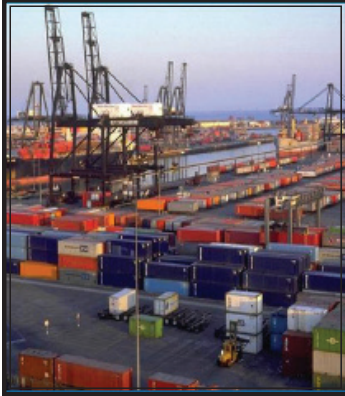

Established in 1990, IVODGA's mission is to assist and support members for the purpose of assuring the safe, efficient and cost-effective transportation of dangerous goods.

An intervention by the IVODGA delegate convinced the DSC to alter their decision and to not adopt a new onerous amendment that would have required retro-fitting ships with larger lashing platforms costing our industry millions of dollars at a time that the ocean carriers are already experiencing financial challenges.

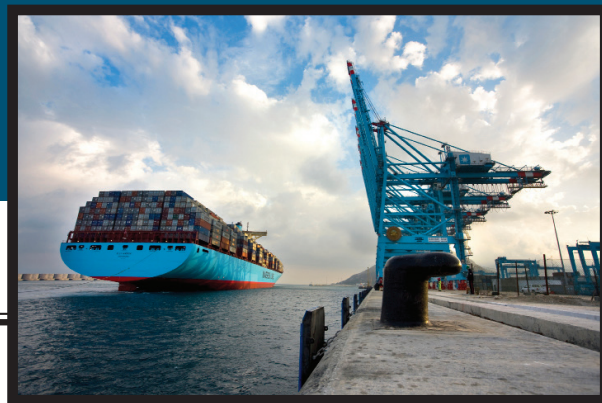
